The essential commitment of the Wayne Township Trustee's Office is to provide prompt, necessary relief to eligible citizens and residents of our community.

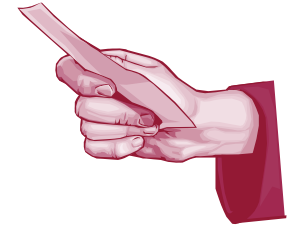
It is dedicated to the important role of providing temporary emergency assistance to those whose personal efforts have not enabled them to meet life's challenges on their own.

## ***Wayne Township Trustee's Representative Payee Program***

In an effort to further serve the citizens of Wayne Township, the Payee Program was implemented in January 2001.

This **free** program ensures that the current needs of social security beneficiary's are met on a monthly basis. This includes food, shelter, medical care and other items for the beneficiary's personal comfort. If any money is left after meeting day-to-day and personal needs, it is saved.

Social Security benefits are directly deposited into a bank account. This method is safe and secure.

## ***Program Requirements...***

- ◆ Must be a beneficiary of some type of Social Security.
- ◆ Must be 18 years of age or older.
- ◆ Must be a resident of Wayne Township.
- ◆ Must be deemed by a physician unable to manage their own financial affairs.
- ◆ DO NOT have to be recipients of Wayne Township's Township Assistance.
